Extinguishing Media

3. HEALTH HAZARD INFORMATION

Potential Health Effects, Skin

Not expected to be irritating.

Potential Health Effects, Eye

SEVERELY IRRITATING

Potential Health Effects, Inhalation

SLIGHTLY TO MODERATELY IRRITATING. Prolonged overexposure may cause coughing, shortness of breath, dizziness and intoxication.

4. FIRST AID INFORMATION

Skin

Remove contaminated clothing and launder before reuse. Wash affected skin areas with soap and water. See a physician if irritation persists.

Eye (SEVERELY IRRITATING)

If symptoms develop, move individual away from exposure and into fresh air. Flush eyes gently with water while holding the eyelids apart, GET IMMEDIATE MEDICAL ATTENTION

Inhalation (SLIGHTLY TO MODERATELY IRRITATING)

Move subject to fresh air. If having difficulty breathing, administer oxygen. Give artificial respiration if breathing has stopped. Call a physician.

Ingestion

Seek medical attention. If individual is drowsy or unconscious, do not give anything by mouth; place individual on the left side with head down. Contact a physician, medical facility, or poison control center for advice about whether to induce vomiting. If possible, do not leave individual unattended.

In all of the above emergency cases, call a physician.

5. REACTIVITY INFORMATION

Stability / Incompatibility

Stable. Incompatible with strong acids, strong alkalis, strong oxidizing agents.

Hazardous Reactions / Decomposition Products

May form carbon dioxide and carbon monoxide.

Hazardous Polymerization

Not expected to occur.

6. SPILL OR LEAK PROCEDURES INFORMATION

Emergency Action

Eliminate and/or shut off any ignition source and keep ignition sources out of the area. Evacuate the area of all unnecessary personnel. Thoroughly ventilate the area, use self-contained breathing apparatus. Wear protective equipment if exposure conditions warrant.

Spill or Leak Procedure

Eliminate and/or shut off any ignition source and keep ignition sources out of the area. Shut off leak if safe to do so. Absorb spill with inert material (e.g. dry sand or earth) then place in a chemical waste container. Use water spray to dilute spill to a nonflammable mixture. Avoid run-off into storm sewers and ditches, which lead to waterways.

7. SPECIAL PROTECTION INFORMATION

Skin Protection: Personal Protection Equipments (PPE)

If skin contact is anticipated, protective clothing, including gloves, should be worn.

Eye Protection: Personal Protection Equipments (PPE)

Wear chemical safety goggles
Have eye-washing facilities readily available where eye contact can occur.

Respiratory Protection: Personal Protection Equipments (PPE)

Good general ventilation should be sufficient to control airborne levels.

8. STORAGE AND HANDLING EQUIPMENT

Handling

Wash hands thoroughly before eating, drinking or smoking. Store below 120 degrees F in a tightly closed container in a cool, dry, isolated, well ventilated area, away from heat, ignition sources and incompatibles. Store out of direct sunlight. Use non-sparking tools.

Storage

Store in tightly closed containers in a cool, dry, isolated, well ventilated area away from heat, source of ignition and incompatibles.
